With reference to the subject cited, I wish to inform you that, "Vigyan Prasar", an autonomous organization under the Department of Science & Technology, Government of India, in association with the NCERT and Vijnana Bharathi (an NGO led by eminent scientists) is conducting a National level talent search examination named "Vidyarthi Vigyan Manthan" (VVM), which is claimed to be India's largest science talent search for New India.

Further, students from the Class VI to XI studying under CBSE, ICSE and state boards are eligible to appear for the examination, which is being held online on 29<sup>th</sup> October 2023 or 30<sup>th</sup> October 2023 in the Online mode and awards and scholarships are being awarded by the organizers to the best performers of the VMM examination.

Further, the students are allowed to take the examination from a digital application developed for this purpose and both Individual student registration and school-wise bulk registrations were made available to encourage the participation of more students. More details regarding the examination, registration process, benefits of the examination etc. are detailed in the brochure which is enclosed with this letter.

In view of the above, I request you to kindly take necessary measures to increase awareness and provide wide publicity among the students of the 6<sup>th</sup> to 10<sup>th</sup> classes in your concerned schools and persuade the students to voluntarily register (before 15<sup>th</sup> September 2023) and appear for the examination for their benefit and to utilize this opportunity to identify and showcase the bright minds with scientific aptitude from the student community.
