As intimated vide e-mail dated 09.07.2024 received from Dy. Director General, National Council of Science Museums (NCSM), Ministry of Culture, Govt. of India, regarding the above subject.

VIDYARTHI VIGYAN MANTHAN (VVM) is a national program for popularizing science among school students of standard VI to XI, conceptualized with the intent of identifying "ignited minds" which is an initiative of Vijnana Bharati (VIBHA), in collaboration with National Council of Educational Research and Training (NCERT), an institution under the Ministry of Education, Government of India and National Council of Science Museums (NCSM), an autonomous organization under the Ministry of Culture, Government of India.


Details of VVM are hereunder:

1. **Date of Examination:** 23rd October, 2024 or on 27th October, 2024.
2. **Time of Exam:** Anytime from 10:00 a.m. to 06:00 p.m.
3. **Eligibility:** All students from classes 6th to 11th are eligible to participate.
4. **Fee: Registration fee** INR 170 per student only if registration done at school level. In case if registration done at individual level, fee will INR 200 per student.
5. **Mode of Examination:** Online (through Desktop, Laptop, Tablet, Mobiles)-App based
6. **Examination Duration:** 1 Hour 30 Minutes.
7. **Registration Deadline:** 15th September, 2024.
8. **Mode of Registration:** Online Registration at school level (Minimum of 10 students per class for school level registration).
9. The Principal need to appoint the school coordinator who will register the school and the students as per the instruction given in attached enclosure. A certificate will be awarded to the school coordinator for their role in registering students and conducting the Vidyarthi Vigyan Manthan (VVM) at the school level.
